What is this product?

Type:

Société d'Investissement à Capital Variable [SICAV]

Term:

This product is not subject to any fixed terms.

Objectives:

The objective of the Compartment is to provide long term capital appreciation. The Compartment is actively managed, investing substantially all of its assets in various sub-funds of VAM Funds (Lux), a UCITS fund domiciled in Luxembourg. The Compartment's investment manager updates the allocation of the sub-funds following an analysis that balances the Compartment's investment objective and the Compartment's administrative purpose of providing broad exposure to the underlying sub-funds. However, no more than 20% of the Compartment's net assets will be allocated to a single sub-fund of VAM Funds (Lux). In addition, the Compartment may invest up to 100% of its net assets, for defensive purposes and on a temporary basis, in bank deposits as well as invest in money market instruments, money market UCIs, cash or short-term fixed income instruments. The Compartment may invest in financial derivative instruments only for the purpose of hedging risks. In principle you can sell shares of the Compartment on every full bank business day. Income remains in the Compartment and is reinvested.

Intended Retail Investor:

This product is intended for professional and private investors who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed for investors seeking to invest in an actively managed portfolio of certain growth equity-related compartments of VAM Funds (Lux), a Luxembourg UCITS.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 Years. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.



The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.

What happens if Limestone Platform AS is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Caceis Bank, Luxembourg Branch. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods:

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- EUR 10 000 is invested.
